Entry Fees: (TEAMS OF 10 OR MORE CALL/EMAIL BEFORE REGISTRY FOR DISCOUNT CODE)

- \$25 per wrestler “team fee” of 10 or more wrestlers – \$20 per wrestler for teams of 20 or more
- \$35 per wrestler “individual fee” or teams less than 10 wrestlers
- \$15 Double Entry (higher age bracket) (complete and pay for second entry, get discount at tournament)

Coaches Admission: 4 free coaches; \$5 per coach after 4.

General Admission: **CASH ONLY** – \$5 adults; \$3 (ages 17-6); Children 5 and under are free.

Early Weigh Ins: 1/18/25, 6:00 PM – 8:00 PM @ BCHS (1lb allowance) (2lb for 15U)

Weigh Ins: 1/19/25, 6:00 AM – 8:00 AM @ BCHS (scratch meeting to follow) (1lb allowance) (2lb for 15U)

Must weigh in a singlet or shorts and t-shirt! Wrestling begins after scratch meeting.

Rules: Wrestlers enter the age group according to birth years listed. — Wrestlers may double enter, IN HIGHER AGE BRACKET. — Double Elimination Brackets and Round Robin for classes with 5 or less entries. — Wrestlers will wrestle (3) 1-minute periods. 15U will wrestle (3) 1.5 minute periods. — Scholastic rules apply with sudden death overtime. — We reserve the right to combine weight classes to maximize competition. — \$10 bump up fee. — Proof of age (if challenged). — **NO HIGH SCHOOL WRESTLERS!!** — Effort will be made to separate wrestlers from the same team. — Registered officials used; their decision is final. — **BELLIGERENT BEHAVIOR WILL NOT BE TOLERATED.**

Awards: Individual awards are given to 1st, 2nd, 3rd, and 4th place finishers in each weight class.

Girls Division: Madison System will be used to create bouts. Girls are permitted to wrestle in regular open tournament and may double enter the 2 divisions (open and girls) in the same age brackets.
